USING THE EQUIPMENT THAT CONTAINS THIS PRODUCT, YOU ARE CONSENTING TO BE BOUND BY THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, CLICK THE "DO NOT ACCEPT" BUTTON AND THE INSTALLATION PROCESS WILL NOT CONTINUE, RETURN THE PRODUCT TO THE PLACE OF PURCHASE FOR A FULL REFUND, OR DO NOT DOWNLOAD THE PRODUCT.

Single User License Grant: A&H Software House, Inc. ("A&H") and its suppliers grant to Customer ("Customer") a

nonexclusive and nontransferable license to use the A&H Software House, Inc ("Software") solely on a single central processing unit owned or leased by Customer or otherwise embedded in equipment provided by A&H Software House, Inc.

Multiple-Users License Grant: A&H Software House, Inc. ("A&H") and its suppliers grant to Customer ("Customer") a

nonexclusive and nontransferable license to use the A&H Software House, Inc. ("Software"): (i) installed in a single location on a hard disk or other storage device of up to the number of computers owned or leased by Customer for which Customer has paid a license fee ("Permitted Number of Computers"); or (ii) provided the Software is configured for network use, installed on a single DVR server for use on a single local area network for either (but not both) of the following purposes: (a) permanent installation onto a hard disk or other storage device of up to the Permitted Number of Computers; or (b) use of the Software over such network, provided the number of computers connected to the server does not exceed the Permitted Number of Computers.

Customer may only use the programs contained in the Software (i) for which Customer has paid a license fee (or in the case of an evaluation copy, those programs Customer is authorized to evaluate) and (ii) for which Customer has received a product authorization key ("PAK"). Customer grants to A&H Software House, Inc or its independent accountants the right to examine its books, records and accounts during Customer's normal business hours to verify compliance with the above provisions. In the event such audit discloses that the Permitted Number of Computers is exceeded, Customer shall promptly pay to A&H Software House, Inc the appropriate licensee fee for the additional computers or users. Customer agrees to implement reasonable security measures to protect such trade secrets and copyrighted material. Title to Software and documentation shall remain solely with A&H Software House, Inc.

What is "Product Update"?

-Luxriot product Update service, is a service that keeps you informed about new software releases.

-No data is collected that contains any personal information.

You can use the Update Service in two ways:

-By accessing the Luxriot web site.

-By using the Product Update" link located in OPTIONS under tools in the main client software.

What data is collected?

The Update Services collects information from your computer that allows us to operate and improve our services, such as:

-Current Workstation Locale (OS language settings)

-An identifier “that does not contain any personal information” which is believed to be unique for workstation, which is encoded string internally including:

-current time, time of temporary directory creation, latest temporary file access time

-disk C: serial number

-MAC addresses

Same identifier as above, but generated at install/activation

-Luxriot client software version

-Brief statistics on hardware set up with server (such as camera vendor/models)

-Host name or IP address

-Product ID – the unique product license identifier that is included with LuxRiot.

-Product Key – the string of numbers and characters that comes with all LuxRiot editions, typically entered by you during setup to successfully install a product.

-We use this information to help operate and improve our products and services.
